



**PREGAME BUYER TERMS & CONDITIONS**  
**11 NOVEMBER 2025**  
**NEW ORLEANS**

**1. DEFINITIONS AND INTERPRETATION**

- 1.1. In these terms & conditions: **SET** means **Specialists in Entertainment Travel Ltd.**; **Materials** means all materials, drawings, logos, images, tools, equipment, specifications and data in whatever media or format including without limitation the Promotional Materials created or developed by **This is Beyond Limited** or **SET**, its officers, employees, agents or contractors in connection with the Pregame; **Application** means the application or booking form from the proposed Buyer and accepted by **SET** as an 'Approved Buyer' (which shall exclude any invitation issued by **SET**); **Buyer** means the person and/or company whose details are set out in the Application; **Buyer Information** means the Buyer's company name and any other company information related to the **Buyer** and any **Delegate** of such person or company; **Contract** means these terms and conditions between the Buyer and **SET** for the Buyer to attend the Pregame which includes the Application; **Control** means the beneficial ownership of more than 50% of the issued share capital of a company or the legal power to direct or cause the direction of the general management of the company, and Controls, Controlled and the expression change of Control shall be construed accordingly; **Delegate** means any person sent and authorised to represent the **Buyer** at **SET**; **Event** means the **Pregame**; **Pregame** means the one-day thought leadership programme the day before SET (on Tuesday 11 November 2025); For hosted buyers, a **Pregame Pass** gives you access to the Pregame; **Exhibitor** means any person or entity attending the Pregame in such capacity; **Force Majeure** means, in relation to either party, any circumstances beyond the reasonable control of that party including but not limited to any acts of god, epidemics, pandemics, COVID-19 (including but not limited to the COVID-19 pandemic), coronavirus, swine flu, bird flu, and any mutations of any of them, fires, explosions, earthquakes, floods, volcanic eruptions, ash clouds, storms, tempest, lightning, climate change, strikes or lockouts, riots, civil commotions, war, rebellion, or harmful acts for political reasons, any terrorist, biochemical attacks, cyber attacks, national mourning or other similar national or regional event or purposes, material or national emergency, terrorist or military activity, labour disputes, airlines disturbances or cessation, civil disturbances, explosions, inevitable accident, failure of third party suppliers, failure of network and communications providers, failure of utility supply of any kind e.g. water, gas, electricity, interventions, government actions or regulations or

restrictions by national or local authorities or in each case any circumstances, events, consequences or occurrences arising from or associated with any of these things or matters defined as Force Majeure in this clause; **GBP and £** means British pounds sterling; **Hosted Buyer** means any Buyer accepted as a Hosted Buyer upon request made by the Buyer in the Application; **Hotel Cost** means the cost of the hotel provided by **LE** to the Buyer on a complimentary basis; **Intellectual Property Rights** means patents, utility models, rights to inventions, copyright and neighbouring and related rights, moral rights, trademarks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world. **Materials** means all materials, drawings, logos, images, specifications and data supplied by the Buyers to **SET** in connection with the Pregame; **Official Function** means ONLY an event or function organised or promoted by **SET**; **Participation Fee** means the fee payable by the Buyer in accordance with clause 5.3; **Promotional Material** means the promotional brochure or other marketing materials produced by **SET** in relation to the Pregame; **Rules & Regulations** means regulations of the Venue or the regulations **SET** provided from time to time to the Buyer including any guide to the Pregame; **Services** means the services to be provided by **SET** to the Buyer under these Terms; **Single Participation Fee** means the amount of fee payable by the Buyer in accordance with clause 5.2; **Start Date** means the original start date of the Pregame stipulated by **SET** at the time when the Pregame is first promoted; **End Date** means the original end date of the Pregame stipulated by **SET** at the time when the Pregame is first promoted; **SET IPRs** means all Intellectual Property Rights subsisting in the Pregame and the **SET Materials** [excluding any Buyer Information incorporated in them]; **Taxes** means those taxes payable by the Buyer as set out in clause 12.1; **Terms** means these terms and conditions; **Venue** means the site at which the Pregame is to be held as stipulated from time to time by **SET**. A reference to applicable laws, a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time and includes any subordinate legislation made from time to time under the same. Any words following the terms **including, include, in particular, for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms. A reference to **writing** or **written** includes email.

## **2. TERMS OF THE CONTRACT**

- 2.1. The terms of this Contract constitute the entire contract between the parties, superseding and extinguishing all previous contracts, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter. All other terms, invitations, representations or statements whether oral or in writing, expressed or implied by statute or otherwise, are excluded to the fullest extent permitted by law. The Buyer accepts that save for the terms of this Contract, no reliance has been made on any such representations or statements when entering into the Contract and that by entering into the Contract, it does not rely on and shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in the Contract. The Buyer agrees that it shall have no claim for innocent or negligent misrepresentation based on any statement in the Contract.
- 2.2. Any variation or amendment to the Contract must be agreed in writing by a duly authorised person on behalf of **SET**.
- 2.3. Subject to the terms of this Contract in respect of Force Majeure, cancellation or postponement, **SET** may, from time to time, vary or amend any of the Terms, provided that such variations or amendments do not operate to materially diminish or adversely affect the rights reserved to the Buyer under the Contract.
- 2.4. Any dates or times given in this Contract which relate to or reference the Start Date shall mean the original Start Date and not any new Start Date as a result of any postponement or cancellation or change unless **SET** stipulates in writing that any specific Terms shall be amended or varied to reflect or reference the new Start Date.

## **3. HOSTED BUYERS**

- 3.1. Hosted Buyers will receive the following:
- 3.1.1. A pass to the **Pregame**.
  - 3.1.2. Access to the **SET** official function and programming that takes place on the date of the Pregame.

#### **4. TRAVEL & ACCOMMODATION**

##### **Travel**

- 4.1. The Buyer shall be responsible for arranging all travel requirements to and from the Pregame at their own costs including their own transfers to and from the airport for all arrivals and departures.
- 4.2. The Buyer shall be responsible for covering accommodation on the night of Tuesday 11 November 2025 (the Pregame).
- 4.3. Buyers are responsible for arranging their own transfers to and from the airport for all arrivals and departures.

#### **5. CANCELLATION OR AMENDMENT**

- 5.1. The Buyer agrees and acknowledges that in the **Pregame**, that **SET** has put time, operational, promotional and labour cost as well as other expense into arranging such a Scheduled Event including development time. The Buyer acknowledges and agrees that they shall be liable to pay to **SET** an arrangement fee in the amount of **£250** (and in accordance with the Rules and Regulations for **SET**) if the **Pregame** is not attended by the Buyer.
- 5.2. In the event the Buyer cancels their participation in the **Pregame** or a substantial part thereof more than 60 days prior to the Start Date, no additional fees will become due and/or payable. The following fee (each a "**Participation Fee**") is due and payable (as applicable), in the event that the Buyer cancels their participation in **SET's Pregame** programme or a substantial part thereof or fails to attend the show:
  - 5.2.1. £250 if cancellation is 60 days or less prior to the Start Date, unless a qualified replacement is provided by the Buyer and accepted by **SET**.
- 5.3. The Buyer may avoid any Single Participation Fee if they can be replaced by a person with the equivalent role and seniority within their organisation, pending approval in writing by **SET** at its absolute discretion.
- 5.4. **SET** shall be entitled to charge an administration fee equal to the value of **£250** should the Buyer submit an Application and then decline attendance upon acceptance.
- 5.5. Any participation or administration fee should be payable to **SET** within 14 days of receipt of an invoice. If the Buyer fails to do so, **SET** will suspend any further invitation to the Buyer and to their company and reserve the right to

extend this suspension to the Pregame or any event organised by This is Beyond Ltd.

- 5.6. The Buyer may cancel any additional delegate badge, products or services order by giving prior notice in writing to **SET** at least 60 days prior to the Start Date without penalty save that where this results in an overpayment being made, such overpayment shall be credited to the Buyer for use towards other products or services provided by **SET**. Where such notice is received by **SET** less than 60 days prior to the Start Date, the Buyer will be liable for 100% of the cost of the badge.
- 5.7. Identification changes to registered badges may be made by the Buyer, under stipulation they must be in writing to **SET** at least 30 days prior to the Start Date without any administration charge arising. Where such notice is received by **SET** less than 30 days prior to the start of the Pregame, the Buyer will be charged an administration fee of £199 per change.
- 5.8. Neither **SET** nor its agents, employees or contractors shall be required to assist the Buyer to obtain any documents necessary for entry into the country where the Pregame is to be held (e.g., passport, visa or ESTA). Any failure of the Buyer to obtain any such documents from the relevant authorities or any failure to arrange travel or accommodation by the Buyer for any of its agents, employees or contractors shall not constitute frustration of the Contract or a Force Majeure event. The Buyer, however, may substitute another person to take their place subject to approval of such person in its absolute discretion by **SET**. In the event of such substitution, the Buyer shall remain the party to and primarily liable and obligated to **SET** under the Contract. The Buyer shall procure that any substituted party shall accept these Terms.
- 5.9. In the event of a breach of these Terms, either party may (without limiting any other remedy) notify the other in writing requesting that the breach be remedied within 30 days if such breach is capable of remedy.
- 5.10. Without prejudice to any accrued rights, either party may (without limiting any other remedy) at any time terminate the Contract immediately by written notice to the other:
- 5.10.1. if the offending party fails to remedy the breach set out by notice pursuant to clause 5.10 to the claimant's reasonable satisfaction.
  - 5.10.2. if one party materially or persistently breaches any of these Terms;
  - 5.10.3. as a result of an act of Force Majeure;
  - 5.10.4. there is a change of Control of the Buyer;
  - 5.10.5. if the other party takes any step or action in connection with its entering administration, provisional liquidation or any composition or arrangement with its creditors (other than in relation to a solvent

restructuring), being wound up (whether voluntarily or by order of the court, unless for the purpose of a solvent restructuring), having a receiver appointed to any of its assets or ceasing to carry on business or, if the step or action is taken in another jurisdiction, in connection with any analogous procedure in the relevant jurisdiction; or

- 5.11. if the Buyer changes the affiliation/agency they were contracted under for **SET** or if **SET** deem (at **SET**'s sole discretion) that the Buyer's business priorities or business direction has changed.
- 5.12. On termination of the Contract for whatever reason:
  - 5.12.1. the Buyer shall immediately pay to **SET** all of **SET**'s outstanding unpaid invoices and interest and, in respect of any payment where no invoice has been submitted, **SET** may submit an invoice, which shall be payable immediately on receipt.
  - 5.12.2. any provision of the Contract that expressly or by implication is intended to come into or continue in force on or after termination or expiry of the Contract shall remain in full force and effect; and
  - 5.12.3. termination or expiry of the Contract shall not affect any of the rights, remedies, obligations or liabilities of the parties that have accrued up to the date of termination or expiry, including the right to claim damages in respect of any breach of the Contract which existed at or before the date of termination or expiry.
- 5.13. In the event of an act of Force Majeure or other event outside the reasonable control of **SET**, the Pregame may be cancelled, postponed or amended (in a format that can be digital, hybrid or otherwise) by **SET** in such manner as **SET** determines in its absolute discretion upon notice in writing to the Buyer. Any amendment to the Pregame under this clause shall include, without limitation, any change to the Venue, timings, style or format of the Pregame (including changing the Pregame from a 'face to face' format to a digital or hybrid format). In such event, the Buyer is still bound by the terms of this Contract including any of those set out under clause 5 (Cancellation or Amendment). The Buyer shall have no entitlement to any refund of any amount due, payable or paid at the time of the cancellation, postponement or amendment. All remaining payments of the Fee shall remain due and payable without deduction, set-off or counterclaim.
- 5.14. In the event of any cancellation, postponement or amendment, **SET** may at its absolute discretion under this clause 5.14, amend this Contract or add or delete Terms to enable the Pregame to be held at the revised time, location or in the revised manner that **SET** determines in its absolute discretion to be necessary taking into account the circumstances and the financial

implications of the same. Any such amendments, additions or deletions shall be notified to the Buyer in writing as soon as practicably possible.

5.15. In the event that **SET** is delivered in a digital format:

5.15.1. the Buyer acknowledges and accepts that any applications, platforms or programs (each a “**Third Party Application**”) which are used by **SET** to enable the delivery of the Pregame in digital format may be subject to additional third-party terms;

5.15.2. the Buyer acknowledges and accepts that **SET** shall not be responsible nor liable for any losses or damages suffered or incurred by the Buyer in connection with its use of any Third-Party Application; and

5.15.3. **SET** shall be entitled to introduce any policies or terms relating to the delivery of the Pregame in digital format to supplement these Terms which shall be binding on the Buyer.

## **6. CONDUCT OF BUYER**

6.1. As a condition to receiving the services provided by **SET**, Buyers hosted by **SET** will be required to adhere to the following:

6.1.1 As an invited member of **SET**'s collective community, the Buyer shall treat other members (Buyers, Exhibitors, Partners, Suppliers and Staff) in a respectful manner. **SET** operates a zero-tolerance policy on disruptive and abusive behaviour (verbal or physical) including without limitation, abusive, offensive, racist, sexist, predatory, drunken or otherwise inappropriate conduct or conduct that brings **SET** or the Pregame into disrepute by any member towards another member of the community. **SET** reserves the right to remove or blacklist any Buyer from all This is Beyond events, who is deemed disruptive to the Pregame or any event, or during any process in the lead up to the Pregame or any event.

6.1.2 The Buyer has a duty and is obliged to actively take part in the **Pregame** and therefore also has a duty, and is obliged to attend the **Pregame**. The Buyer is also obligated to attend the Pregame and all social events according to the official programme of the Pregame. Failure to do so may result in action taken in accordance with clauses 6.2 and 5.3.

6.1.3 The Buyer is prohibited to sell or to be heard selling products, supplies or services to Exhibitors or fellow Buyers throughout the Pregame. Failure to comply with this requirement may result in action taken in accordance to the clause 7.3 and/or exclusion from the Pregame and future events organised by This is Beyond Limited or **SET** without refund of any sums that may have already been paid by that person.

6.1.4 The Buyer is prohibited to display or distribute any political, illegal, immoral or offensive material at the Pregame. No lotteries, games of chance or raffles or

use of audio, lighting or audio-visual will be conducted without the prior written consent of **SET**.

6.1.5 The Buyer shall comply with all reasonable instructions of **SET**, the venue operator and statutory regulations and the rules & regulations.

6.2. The Buyer shall comply with: (a) all applicable laws; (b) the Rules & Regulations and all health & safety guidelines issued by the Venue or **SET** from time to time; and (c) all reasonable instructions of **SET** and the Venue issued from time to time. Some of these will be updated and edited throughout the period up to and including finalisation of arrangements for the Pregame and during the Pregame itself. The Buyer shall in addition co-operate with **SET** in all matters relating to the Pregame and provide, in a timely manner, such information as **SET** may reasonably require, and ensure that it is accurate and complete in all material respects.

6.3. The Buyer shall be responsible for the conduct of its employees, agents, contractors and guests at all times. In the event of any conduct that is not within the standards of normal, professional or reasonable behaviour expected in the workplace, including as set out in clause 6.1.1, the offending person may be removed from the Venue by **SET** at its absolute discretion and any re-entry cancelled, suspended or made subject to conditions as **SET** requires at its absolute discretion. Persistent or serious offences by a Buyer under this clause will be deemed a material breach of the Contract.

6.4. The Buyer acknowledges and accepts that **SET** does not have any control of and therefore cannot reasonably accept any liability in respect of the conduct, behaviour, response or actions of any third parties.

## **7. INTELLECTUAL PROPERTY**

7.1. This is Beyond Limited or **SET** and their licensors shall retain ownership of all their Intellectual Property Rights. Unless expressly stated otherwise, This is Beyond Limited or **SET** and their licensors shall own any works, information, data or other materials created in connection with the Pregame. The Buyer and its licensors shall retain ownership of all Intellectual Property Rights in the Buyer Information.

7.2. **SET** grants the Buyer or shall procure the direct grant to the Buyer of, a fully paid-up, worldwide, non-exclusive, royalty-free, non-transferable licence to use the **SET** Materials solely for the purpose of attending the Pregame.

7.3. The Buyer grants **SET** a fully paid-up, worldwide, non-exclusive, royalty-free, non-transferable licence to copy and modify the Buyer Information for the purpose of providing the Pregame, Services, Space and Stand to the Buyer in accordance with the Contract including using the Buyer Information in the **SET** Materials.

- 7.4. The Buyer shall indemnify **SET** in full against any loss or damage suffered by **SET** arising of or in connection with any claim brought against This is Beyond Limited or **SET** for infringement of a third party's rights (including any Intellectual Property Rights) arising out of, or in connection with, the receipt or use of the Buyer Information by **SET**.

## **8. INDEMNITY**

- 8.1. The Buyer shall indemnify and hold harmless **SET** against any loss, damages, costs, expenses or other claims arising from:
- a) breach of these Terms by the Buyer, its employees, agents or contractors; and
  - b) breach of any duty or any other tort in connection with any acts or omissions of the Buyer, its employees, agents or subcontractors, whether negligent or otherwise, as applicable.

## **9. LIMITATION OF LIABILITY**

- 9.1. Except in respect of death or personal injury caused by negligence or as a result of fraud, neither **SET** nor the Buyer or any of their employees, agents or contractors shall be liable to each other by reason of any representation, or any implied warranty, condition or other term, or in tort (including without limitation negligence) or any duty at common law or under statute, or under the express terms of the Contract or otherwise howsoever arising, for any loss or damage, costs, expenses or other claims whether direct or indirect, being (a) loss of profit or business or opportunity; (b) reputational loss or damage; or (c) any special or consequential loss or damage, which in each case arise out of or in connection with the Pregame (including without limitation any cancellation, amendment or postponement of the Pregame).
- 9.2. Subject to clause 9.1, and except in respect of death or personal injury caused by negligence, **SET's** total liability to the Buyer by reason of any representation, or any implied warranty, condition or other term, or in tort (including without limitation negligence) or any duty at common law or under statute, or under the express terms of the Contract or otherwise howsoever arising, in respect of all loss or damage, costs, expenses or other claims arising from or in connection with the Pregame, shall in no circumstances exceed the Fee unless caused by the fraudulent act or omission of **SET**, its authorised employees, agents or contractors.
- 9.3. Notwithstanding clauses 9.1 and 9.2, and except in respect of death or personal injury caused by negligence or as a result of fraud, neither **SET** nor the Venue operator nor their employees, agents, or contractors shall have any liability to the Buyer by reason of any representation (unless fraudulent), or any implied warranty, condition or other term, or in tort (including without limitation negligence) or any duty at common law or under statute, or under the express terms of the Contract or otherwise howsoever arising, for any loss or damage, costs, expenses or other

claims, whether direct or indirect, which arise out of or in connection with the Pregame (including without limitation any cancellation, amendment or postponement of the Pregame):

- 9.3.1. as a result of an act of Force Majeure; or
- 9.3.2. in relation to the failure of **SET**'s agents or contractors to supply materials for the Stand or any of the amenities for the Pregame; or
- 9.3.3. in relation to the failure of supply of any utilities by any public, government or private provider.

9.4. References in **SET**'s marketing materials to "Guaranteed Scheduled Events" or any reference to a targeted number of delegates shall imply an obligation on **SET** to use its reasonable endeavours to provide such services to a Buyer but subject to availability of such matters or things. However, if **SET** is unable to supply any such matters or things, such failure shall not constitute a breach of this Contract by **SET**.

9.5. **SET** may not benefit from the limitations and exclusions set out in this clause 9 in respect of any liability arising from its wilful default.

9.6. Unless the Buyer notifies **SET** that it intends to make a claim in respect of an event within the notice period, **SET** shall have no liability for that event. The notice period for an event shall start on the day on which the Buyer became, or ought reasonably to have become, aware of the event having occurred and shall expire 3 months from that date. The notice must be in writing and must identify the event and the grounds for the claim in reasonable detail.

9.7. If **SET**'s performance of its obligations under the Contract is prevented or delayed by any act or omission of the Buyer, its agents, subcontractors, consultants or employees, **SET** shall:

- 9.7.1. not be liable for any costs, charges or losses sustained or incurred by the Buyer that arise directly or indirectly from such prevention or delay;
- 9.7.2. be entitled to payment of the Fee or any part of the Fee despite any such prevention or delay; and
- 9.7.3. be entitled to recover any additional costs, charges or losses **SET** sustains or incurs that arise directly or indirectly from such prevention or delay.

9.8. The Buyer acknowledges and agrees that as **SET** is the provider of the Pregame and is not involved or a participant, in any way, in respect of any contact, meetings (face-to-face or otherwise), negotiations, transactions or contracts that are entered into or otherwise agreed between the Buyer and any third parties during or in connection with any Pregames. Consequently, the Buyer acknowledges and agrees that **SET** shall not be liable in any way and/or for any reason whatsoever in respect of any acts or omissions arising from any dealings, arrangements or relationship between the buyer and third parties.

## 10. INSURANCE

- 10.1 The Buyer is responsible for arranging sufficient insurance in relation to:
- (1) their employees, agents, contractors, property and other equipment for which they are responsible; and
  - (2) any participation, accommodation and travel-related expenses.

## 11. CONFIDENTIALITY

- 11.1 Each party undertakes that it shall not at any time, disclose to any person any confidential information concerning the business, affairs, customers, clients or suppliers of the other party or of any associated or group company of the other party belongs which for **SET**, except as permitted by clause 7.2. For the purposes of these Terms: “**group**” means, in relation to a party, that party, any subsidiary or holding company from time to time of that party, and any subsidiary from time to time of a holding company of that party; and “**associated**” means, under the Control of the same person, company or entity.
- 11.2. Each party may disclose the other party's confidential information:
- 11.2.1. to its employees, officers, representatives, contractors, subcontractors or advisers who need to know such information for the purposes of carrying out the party's obligations under the Contract. Each party shall ensure that its employees, officers, representatives, contractors, subcontractors or advisers to whom it discloses the other party's confidential information comply with this clause 11.2;
  - 11.2.2. as may be required by law, a court of competent jurisdiction or any governmental or regulatory authority; and
  - 11.2.3. as expressly permitted under this Contract.
- 11.3. Neither party shall use any other party's confidential information for any purpose other than to perform its obligations under the Contract.

## 12. GENERAL

- 12.1. The Buyer is fully responsible for VAT, GST, sales tax or other analogous taxes or liabilities as required by the local governing authorities. **SET** has no responsibility for the relevant fiscal process relating to such taxes. This is a matter exclusively between the Buyer and the relevant local authorities. **SET** may (but shall not be obliged to) charge VAT, GST, sales tax or other analogous taxes or liabilities on invoices depending on the tax situation of the Buyer and its country of residence. In the event that VAT, GST, sales tax or other analogous taxes or liabilities is properly due and not charged on any relevant invoice, the Buyer shall pay the same on demand from **SET**.

- 12.2. No failure or delay by either party in exercising any of its rights under the Contract shall be deemed to be a waiver of that right, and no waiver by either party of any breach of the Contract by the other shall be effective unless it is given in writing or be considered as a waiver of any subsequent breach of the same or any other provision.
- 12.3. If any provision of these Terms is held by any court or other competent authority to be invalid or unenforceable in whole or in part, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part- provision under this clause shall not affect the validity and enforceability of the rest of the Contract.
- 12.4. **SET** provides approval for private events to take place during the Pregame, so long as the number of Buyers invited does not exceed 10 and provided, they do not clash with the official programme. Any company hosting a private event that clashes with an official element of the event or that has invited more than 10 Buyers will have their registration(s) revoked and will be refused entry to all business and social events throughout the event.
- 12.5. From time to time, private events might be organised by delegates participating in the show. The organisation of such events is not the responsibility of **SET** and **SET** cannot facilitate entry or access to any of those events.
- 12.6. **SET** does not allow any family members or life partners, junior staff or non-delegates to attend any of the official functions or the SET Pregame unless previously agreed.
- 12.7. **SET** is for senior management and employees of the Buyer only. **SET** reserves the right to refuse entry to any junior staff or person under 21 years old or any agents or contractors of the Buyer.
- 12.8. Unless this Contract expressly states otherwise, this Contract shall not give rise to any rights for a third party to enforce any term of the Contract save that any associated or parent company of **SET**, including This is Beyond Limited, is entitled to protect its assets, revenues or Intellectual Property Rights.
- 12.9. Any notice or other communication given to a party under or in connection with the Contract shall be in writing and shall be:
- 12.9.1 delivered by hand at its registered office (if a company) or its principal place of business and be deemed to have been received at the time left at the proper address; or

- 12.9.2 by pre-paid national first-class post or other next working day delivery service at its registered office (if a company) or its principal place of business and be deemed to have been received at 10.00am on the second Business Day after posting; or
- 12.9.3 by pre-paid airmail providing proof of postage or delivery and be deemed to have been received at 10.00am on the fifth Business Day after posting; or
- 12.9.4 sent by email to the email address specified in the Rules and Regulations for **SET** or in the Application (for the Buyer) and be deemed to have been received at the time of transmission, or, if this time falls outside business hours in the place of receipt, when business hours resume.
- 12.9.5 In this clause, business hours mean 9.00am to 5.00pm Monday to Friday on a day that is not a public holiday in the place of receipt and 'Business Day' shall be construed accordingly.
- 12.9.6 This clause does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.
- 12.9.7 The Buyer acknowledges and agrees that on receipt of email confirmation of inclusion of the Buyer onto **SET**'s Buyer programme, this email will constitute formation of a binding contract to attend the Pregame upon the terms of this Contract.
- 12.10. This Contract, and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation, shall be governed by, and construed in accordance with the laws of England and Wales. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non- contractual disputes or claims) arising out of or in connection with the Contract or its subject matter or formation.
- 12.11. This Contract is drafted in the English language. If this Contract is translated into any other language, the English language version shall prevail.
- 12.12. Any notice given under or in connection with this Contract shall be in the English language. All other documents provided under or in connection with this Contract shall be in the English language or accompanied by a certified English translation.
- 12.13. If such document is translated into any other language, the English language version shall prevail unless the document is a constitutional, statutory or other official document.

### **13. USE OF DATA**

- 13.1. **SET** will use the personal information provided to it in connection with this Contract and the provision of the Pregame in accordance with **SET's** Privacy Policy.
- 13.2. The Buyer agrees to notify **SET** of any change to its contact information (including but not limited to its telephone and/or e-mail address).
- 13.3. The Buyer must not provide **SET** with personal information relating to others unless it is lawfully authorised to do so and has passed on a copy of **SET's** Privacy Policy to those individuals.
- 13.4. The Buyer shall procure for its officers, employees, agents and contractors to provide appropriate authorisation under privacy laws to give their company and personal information to **SET** as compiled by the Buyer in their personal profile for the purpose of distribution to other participants in the Pregame and to have them displayed in any Pregame-related publications.
- 13.5. The Buyer shall procure for its officers, employees, agents and contractors to provide appropriate authorisation under privacy laws to be photographed or videoed during the Buyer's participation at the Pregame and that the resulting material may be used for promotional purposes in any media including without limitation in print, on the internet and any digital format. The Buyer confirms that it has all necessary personal authorisations required under clause 13.
